A wedding story told beautifully through cinematic wedding film is not just about the wedding day itself, it's the story within the story. The bride & groom, the family and friends, those special connections.

We're here to capture the love, the joy, the happy tears and the antics. Once in a lifetime moments for you to watch, listen and share forever.

This package is based on the most popular option as it covers the whole day and gives a great cinematic film capturing all those special moments that are more than often missed by the couple due to how hectic the day can be for them.

We capture our footage very unobtrusively and are happy working alongside photographers on the day. There might be a couple of shots we would like to achieve that mean the couple or family being available at a certain time but this is optional and done to make sure it does not interrupt anything else on the day.

As there are two of us present all day it means we can be in more places at once, seeing what others might not to make sure we don't miss a moment.



WEDDING FILM PACKAGE DETAILS:

- A Meeting with you both prior to the wedding day. Ideally this should take place at the venue(s) so we can discuss ideas and the plan of your day.
- All day coverage from bride prep to an hour after your first dance.
(Subject to timings and logistics being possible)
- Two videographers present all day so you don't miss a moment.
- 10 - 15 minute cinematic film of your day.
- Your ceremony recorded with professional audio, edited and supplied as a separate file.
- Speeches recorded with professional audio, edited and supplied as a separate file.
- 1 - 2 Licensed music tracks used within the edits.
(Music is based on non-commercial tracks, if commercial music is required it may incur additional costs.)
- All final films will be digitally delivered for you to download.

WEDDING PACKAGE COST - £1,800.00*

EXTRAS:

- Aerial footage via drone - £300.00
(Subject to venue approval & site survey, restrictions may apply due to weather conditions or the venue)
- Additional shorter edit (2-3 Mins) ideal for sharing on social media - £250.00
(This will be created using footage from the main highlights film)

All footage will be shot in HD. Deliverables will be made as online digital files.

The final wedding video will be delivered within 4 - 6 weeks after the wedding day.

If your wedding requires us to travel more than 20 miles from Chelmsford then additional travel expenses may be incurred.

If your venue is more than 1hrs drive away for us then we will discuss options with you to stay close by the night before to ensure there are no unforeseen hold-ups on the morning of your wedding.

*No two weddings are the same which is why we cannot finalise an exact cost until a detailed itinerary/plan of the day has been provided to agree a cost that ensures all elements of your day can be captured as required.

PAYMENT TERMS & SCHEDULE

This contract is for video services to be provided by The Film Boys the videographer, for the wedding of the named parties on page 3, scheduled at the time and dates listed on page 3.

Upon your signature and payment of the initial deposit of £500, The Film Boys will reserve the date of your wedding as detailed on page 3 of this document, no other reservations for this date will be taken. For this reason, the Reservation Deposit is non-refundable, even if the date is changed or the wedding is cancelled for any reason. This includes acts of god, fire, and/or extreme weather. The Reservation Deposit is applied toward the contracted wedding video package detailed on page 2.

Two further payments will then be required before the date of your wedding. Invoices for these payments will be sent prior to the dates required. Filming cannot take place until all payments have been made in full.

Approximately three weeks prior to the wedding, we must have a complete schedule of your wedding day, the timings, location(s) and overall plan of the day.

It is understood that The Film Boys will act as sole and exclusive wedding videographer of your event.

HOUSE RULES

Videographers are sometimes limited by rules imposed by registrars, photographers, ministers and venue management as to what can and cannot be done. For example, venues may restrict the use of lights or limit access to certain locations. In such circumstances you agree to accept the technical limitations that may be imposed on the equipment used. We advise Clients to make themselves aware of the rules of the venue concerned and if necessary negotiate with the personnel concerned.

FOOD BREAKS

One 30 minute break will be allowed at discretion throughout the day, usually taken during the Wedding breakfast so not to miss any key events, bathroom breaks will be taken when necessary. Each videographer will be provided a full guest meal for weddings that last longer than 5 hours.

INTELLECTUAL PROPERTY

Client(s) acknowledge that all work created under this agreement is the intellectual property of the videographer who shall retain the copyright to the footage. Client(s) may post the video online and agree not to digitally manipulate the work. Any use of the video in featured publications or websites must be accompanied by a credit of "Video By: The Film Boys"

MODEL RELEASE / CONSENT

You grant The Film Boys and its legal representatives, heirs and assigns, the irrevocable and unlimited consent to use the video of the Wedding for editorial, competition, advertising and any other purpose and in any manner and to alter the video without restriction. You hereby release the videographer and its legal representatives, heirs and assigns from all liability and claims in connection with the images included within the videos produced.

You also give consent and approval that all guests and people attending the wedding are happy to be filmed and included in any final edits and films created without limitation.

LIMITATIONS OF LIABILITY

While The Film Boys takes the utmost care with respect to shooting, editing and delivering the video, in the event that the video becomes lost, stolen or destroyed, for reasons within or beyond the control of the videographer, liability is limited to a full refund of any payments already received. The limit of liability shall not exceed the contract price stated herein. The Film Boys will not be held responsible for any ruined video footage due to guests and/or other vendors, or outside of The Film Boys control.

The Film Boys will not include any footage or audio within their edits that includes swearing or inappropriate behavior. This includes the audio for the speeches so please if you would like these featured in length ensure the content does not include swearing or inappropriate content.

Please be aware that if your wedding or event features copyrighted or licensed music in any form then The Film Boys may not be able to include this within the video due to licensing restrictions. If this could be something that affects you it is your responsibility to bring it to The Film Boys attention before the day of your Wedding.

In the event that The Film Boys are unable to video the wedding due to: illness, emergency, accident, or act of god, every effort will be made to find a suitable video replacement. If a replacement is unavailable, any payment(s) already made to The Film Boys will be refunded in full, and return of the payment(s) shall be the entire obligation under this contract. No other damages or guarantees of any kind are recognised or warranted.

In the event that the client(s) reschedule the wedding/event and The Films Boys are able to rebook the new wedding/event date within their schedules The Film Boys will amend the wedding/event date in this contract and client(s) will receive credit for all monies paid up to the date client(s) requests the wedding/event be rescheduled.

In the event that the client(s) reschedule the wedding/event and The Film Boys are NOT able to book the new wedding/event date, the client(s) will forfeit the Reservation Deposit, but receive credit for all other monies paid up to that point.

In the event that the client(s) cancels the wedding/event outright, Client will forfeit all monies paid up to the date of cancellation. Cancellation must be made in writing (print or email) no other communication will be accepted or recorded as cancellation.

BUSINESS INSURANCE

The Film Boys carry public liability insurance of £1 million pounds.

HEALTH & SAFETY

In all instances The Film Boys reserve the right to remove any of its personnel and/or equipment from a location if it is deemed unsafe or if they are subjected to abusive or aggressive behavior. In this instance the Client will be liable for any costs incurred as a result of this.

The Film Boys will observe any venue(s) site safety rules at all times and will liaise with a Health and Safety Manager if deemed necessary.

ACKNOWLEDGE OF AGREEMENT

This Contract incorporates the entire understanding of all parties. Any modifications of this Contract must be in writing and signed by both parties.

To confirm your booking and acknowledge acceptance of this contract, please sign, date, and return to The Film Boys once the deposit payment has been made.
